ARTICLES OF INCORPORATION

OF

JUPITER ISLAND ARTS COUNCIL, INC.

I. the undersigned, acknowledged and file in the office of the Secretary of State of the State of Florida, for the purpose of forming a Florida non-profit corporation in accordance with Chapter 617, Florida Statutes, and the laws of the State of Florida, these Articles of Incorporation, as by law provided.

ARTICLE I. NAME.

The name of the corporation shall be Jupiter Island Arts Council, Inc., a Florida non-profit corporation, hereinafter referred to as the "Corporation."

ARTICLE II. EXISTENCE.

The period of duration of this Corporation is perpetual, unless sooner dissolved according to law.

ARTICLE III. PURPOSE.

The purposes or purposes for which this corporation is organized are exclusively for those charitable purposes within the meaning of Section 501(c) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Revenue law. This corporation shall not be conducted or operated for profit, and no part of the net earnings of this corporation shall inure to the benefit of or be distributable to tis members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make any payments and distributions in furtherance of Section 501(c)(3) purposes.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation from Federal Income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding section of any future Federal tax code).

The Corporation is organized pursuant to Florida Statutes Chapter 617 for the purpose of procuring, managing, maintaining, promoting, and educating the public of local artists residing in Hobe Sound and Jupiter Island.

ARTICLE IV. POWERS.

The powers of the Corporation shall include and be governed by the following provisions:

Section 1. The Corporation shall have all of the common law and statutory powers of a corporation not-for-profit which are not in conflict with the terms of these Articles and the Declaration, and all the powers set forth in the Declaration which are lawful.

Section 2. The Corporation shall have all of the powers reasonably necessary to implement its purpose, including, but not limited to, the following:

- A) To make and amend Bylaws for the Corporation and regulations respecting the use of the Property.
- B) To enforce by legal means the provisions of the Declaration, these Articles and the Bylaws.

ARTICLE V. INCORPORATOR,

The name and address of the Incorporator is Ann Geupel or 53 South Beach Road, Hobe Sound, Florida 33455.

ARTICLE VI. BYLAWS.

The Bylaws of the Corporation shall be adopted by the first Board of Directors. Bylaws may be altered, amended, or rescinded in the manner provided by the Bylaws. The method of election of the Corporation's directors will be stated in the Bylaws.

ARTICLE VII. ADDRESS OF REGISTERED OFFICE & AGENT.

The street address of the registered office of this Corporation in the State of Florida shall be 12000 SE Dixie Highway. Hobe Sound, Florida 33455. The name of the initial registered agent at this address shall be Marc R. Gaylord, Marc R. Gaylord, P.A. 12000 SE Dixie Highway, Hobe Sound, Florida 33455. The Board of Directors may from time to time move the registered office to any other address in Florida.

ARTICLE VIII. ORGANIZATION.

The Corporation is organized exclusively for charitable, educational, religious, or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal Tax code).

ARTICLE IX. DISSOLUTION.

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding Section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
