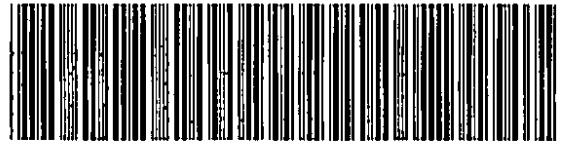

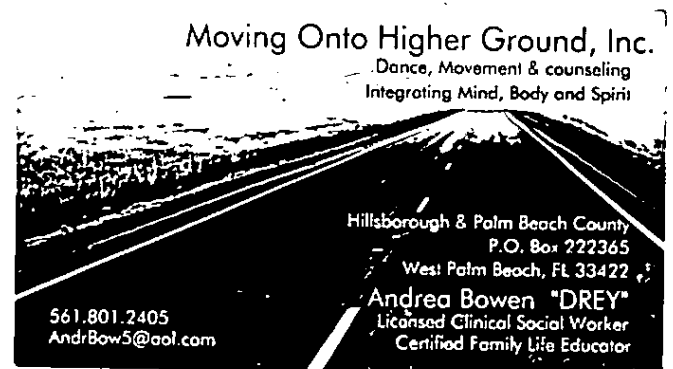

Articles of Incorporation of Moving Onto Higher Ground, Inc., the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of State of Florida, do hereby certify:

First: The name of the Corporation shall be Moving Onto Higher Ground, Inc.

Second: The place in this state where the Principal Office of the Corporation is to be located is: City of Jacksonville, FL 2411-1 Whispering Woods Blvd. Duval County, FL 32246. **Mailing address is PO BOX 222365 West Palm Beach, FL 33422.**

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Public charity organization is established to provide child-centered and family-focused dance/movement instruction. Corporation will provide educational workshops, presentations and seminars on teaching positive, safe and healthy relationship skill-building techniques.

Fourth: Provide the service of individual, group and family psychotherapy. Utilize holistic health and wellness of mind, body and spirit to promote "Peace and Harmony" of the human condition. Corporation will promote PREVENTION of interpersonal violence, i.e. (sexual assault, domestic violence, child abuse, suicide, bullying and sexual harassment) through training, teaching, mentoring and coaching youth and adults in a variety of settings to include schools, work place, corporations, aftercare programs, hospitals and military installations. corporation are as follows:
