In accordance with Florida Statutes Section 617.1401, **FRY FAMILY FOUNDATION CORPORATION**, a Florida not for profit corporation (the "Corporation"), hereby adopts, delivers, and files these Articles of Dissolution for the purpose of dissolving the corporation.

1. The name of the corporation is **FRY FAMILY FOUNDATION CORPORATION**.

2. The Articles of Incorporation of the Corporation were filed on April 3, 2018 and assigned document number N18000003726 by the Florida Department of State.

3. Dissolution of the Corporation was authorized on July 26, 2022 by the written consent of Board of Trustees of the Corporation in accordance with Section 617.1401, Florida Statutes. There are no members entitled to vote.

4. The Corporation has not commenced to conduct its affairs.

5. No debts of the Corporation remain unpaid.

6. A majority of the Board of Trustees authorized the dissolution.

6. The dissolution of the Corporation shall be effective upon filing.
