ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (not for profit)

ARTICLE I

The name of the Corporation is:

ARTICLE III

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV

The purposes for which the corporation is formed is:

- a. To provide orphaned children, mentally and/or physically handicapped children, who are housed in institutions and/or orphanages, with team members who will hold, comfort, rock, feed, hug, and play with the children.
