

Article VI Voting Rights is hereby deleted in its entirety and replaced with the following provisions:
The Association has two classes of voting membership:
(a) Class A. So long as there is a Class B membership, Class A members are all Owners except the Developer and are
entitled to one vote for each Lot owned. Upon termination of Class B membership, Class A members are all Owners,
including Developer so long as Developer is an Owner.
(b) Class B. The Class B member shall be the Developer who shall be entitled to ten (10) votes for each Lot owned by the
Developer. The Class B Membership shall cease and be converted to Class A Membership on the happening of either of the
following events, whichever occurs earlier:
