Articles of Incorporation

FL Independent Pharmacy Association, Inc.

The Corporation is organized and shall be operated on a not-for-profit basis and exclusively for social welfare within the meaning of Section 501 (c) (4) of the Internal Revenue Code (or the corresponding provisions of any future United States federal tax law). The specific purposes of this corporation are: 1. To promote and educate the public regarding the role of independent pharmacies in the Florida health care system;

- 2. To promote the importance of an independent pharmacy network in Florida
- 3. To address legislative, regulatory, and administrative matters regarding independent pharmacies and the health care industry.
- 4. To provide resources, support, and efficiencies that assist independent pharmacies in conducting business in Florida, including identifying potential non-pharmacy partners, collaborators, and third-party contractors such as wholesalers, pharmacy services administration organizations, group health insurers, and others.
- 5. Facilitating, networking, and cooperating efforts among independent pharmacies, as well as other interested groups, to further the above purposes.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf on any candidate for public office.

The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income of assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Furthermore, the net earnings of this corporation shall be devoted exclusively to charitable and educational purposes. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable or educational purposes and which has established its tax exempt status under Section 501(c)(4), Internal Revenue Code.
