

To Whom It May Concern:

The corporation known as African American Women in Physics, Inc., is re-filing for incorporation after its nonprofit status was rendered inactive due to a bounced check. The corporation had initially filed for incorporation in October of 2017. The articles had been accepted by the Secretary of State and the corporation later went on to apply for and receive 501(c)(3) tax-exempt status with the IRS.

It was brought to the attention of the President that the corporation lost its nonprofit status at the state level in April of 2018 because a check written by ExemptMeNow had bounced. This is not the fault of the corporation, but of ExemptMeNow for closing the bank account to which the written check was attached following the acceptance of the filed Articles of Incorporation.

The CEO of ExemptMeNow was in touch with the Division of Corporations following this error, and she was ensured that the corporation could re-file for Articles of Incorporation using the same corporation name, and that attaching a letter to explain the situation would clear up any questions that may prevent the Division of Corporation from accepting the articles. ARITCLE III: PURPOSE

The purpose of form for the corporation, known as African American Women in Physics, Inc., or AAWIP, is twofold: 1) To stimulate diversity in physics and other STEM fields by enhancing the visibility of African American Women in Physics, and 2) to encourage and facilitate the personal and professional growth of African American Women in Physics through volunteering, mentoring, and the sharing of best practices.

The corporation is organization exclusively for charitable, religious, educational, or scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
