

## MARINA POINTE EAST CONDOMINIUM ASSOCIATION, INC.

(A Florida corporation not for profit)

Pursuant to Chapter 617.1006 of the Florida Not For Profit Corporation Act

JOSHUA BREAKSTONE. Secretary of MARINA POINTE EAST CONDOMINIUM ASSOCIATION, INC., a Florida corporation not for profit ("Association"), does hereby certify under the seal of the Association as follows:

- The Association was originally incorporated on April 19, 2018, Document Number N18000004415, under Chapter 617 of the laws of the State of Florida.
- 2. Article XIV, Section A, of the Articles provides that prior to the recording of the Declaration amongst the Public Records, these Articles may be amended by an instrument in writing signed by the President (or a Vice President) and the Secretary (or an Assistant Secretary) and filed in the Office of the Secretary of State of the State of Florida.
- Article V of the Articles provides that until such time as the Land is submitted to condominium ownership by the recordation of the Declaration, the membership of this Association shall be comprised solely of the members of the "First Board" (as defined in Article X thereof).
  - 4. As of the date of this Certificate, the Declaration has not been recorded.

- Article X, Board of Directors, Section A, is hereby amended to read as follows: 1.
  - A. The number of Directors on the first Board of Directors of the Association ("First Board"), the "Initial Election Board" (as hereinafter defined) and all Boards elected prior to the Annual Members' Meeting following the "Developer's Resignation Event" (as hereinafter defined) shall be no less than three (3) nor more than five (5) seven (7), as the Board shall from time to time determine prior to each meeting at which Directors are to be elected. The number of Directors elected by the Members subsequent to the Developer's Resignation Event shall be as provided in Paragraph G of this Article X. Except for Developer-appointed Directors, Directors must be Members or the parents, children or spouses or officers or directors of Members, except that if a Unit is owned by an entity and not an individual, such entity may appoint an individual on
