#### Article 1.

The name of the corporation is Florida's Youth Fishing Foundation, Inc.

#### Article 2.

The initial registered office of the Corporation shall be at: 2627 Yukon Cliff Dr, Ruskin, FL 33570. The initial registered agent of the Corporation at such address shall be: Scott E. Kula.

#### Article 3.

#### Article 5.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific purpose of the organization is to give the underprivileged youth the opportunity to get out and experience the wonderful recourses that we have in our water ways by giving them the opportunity to get out and learn the dynamics about fishing and being on the water while being safe on boats.

#### Article 8.

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
