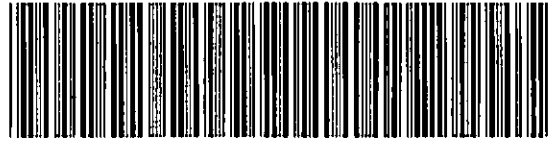

IN COMPLIANCE WITH CHAPTER 617, F.S., (NOT FOR PROFIT)

### ARTICLE I NAME

THE NAME OF THE CORPORATION SHALL BE: FIRST STEP SECOND CHANCE INC.

### ARTICLE II PRINCIPAL OFFICE

### ARTICLE III PURPOSE

THE PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED IS:

WOMEN EMPOWERMENT DESIGNED TO ASSIST WOMEN WITH BUILDING THE INNER STRENGTH BY BECOMING POSITIVELY PRODUCTIVE AND FACING CHALLENGES OF DISABILITIES THAT WE HAVE IN OUR LIFE TODAY. WE WILL BE OVERCOMERS EACH ONE REACH ONE AND EACH ONE TEACH ONE IN OUR ORGANIZATION HELPING ONE ANOTHER ENRICH OTHERS BY CREATING NEW LIVES AND REDIRECTING PATHS ONE STEP AT A TIME. ## ARTICLE VI LIMITATIONS

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR DISTRIBUTABLE TO ITS MEMBERS, TRUSTEES, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSES SET FORTH IN ARTICLE III HEREOF.

NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE.
