As part of our application for recognition of exemption from federal income tax, we agree to make the following amendment to our organizing document. Since the organization is incorporated, the amendment will be filed with and approved by the appropriate state official.

Article III. The specific purpose for which this corporation is organized is:

The organization is organized exclusively for charitable, religious, educational, scientific, literacy purposes and/or fostering national or international amateur sports competition under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The organization is further organized to engage in activities that will empower underprivileged families and build relationships that will lessen the burdens of government, lessen neighborhood tensions, and combat community deterioration and juvenile delinquency through the advancement of after school educational and weekend sports programs.

THIS AMENDMENT REPLACES ARTICLE III OF OUR ARTICLES OF INCORPORATION

Article IX. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501 (c) (3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
