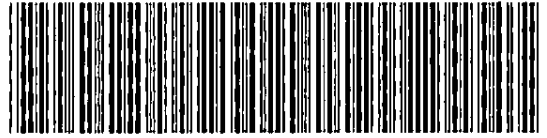


ARTICLES OF DISSOLUTION

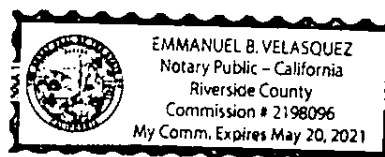




RESOLUTION
