

Article III of the Articles of Incorporation is deleted in its entirety and will be replaced by the following language:

The corporation is organized for the purpose of advancing environmental conservation through education, activity, and research, in an effort to benefit society and preserve and enhance our Earth's natural environments and ecosystems. To further the corporation's purposes and objectives, as stated herein, the corporation will, among other activities, research the effects of human beings on global homeostasis; research the causes and effects of greenhouse gas emissions and the various solutions to climate change; implement and promote carbon-reducing technologies; implement the reduction of non-biodegradable materials and promote the use of biodegradable single-use products; arrange and sponsor beach and park clean-up events; and endeavor to prevent and reverse habitat loss.

The corporation is organized exclusively for charitable, religious, educational and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
