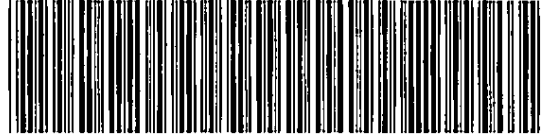

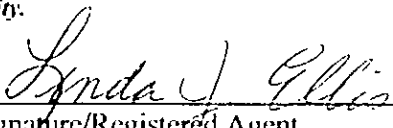

CHARTER OF CHRISTIAN CHURCH

SEBRING, FLORIDA.

We, the undersigned, desiring to associate ourselves together and to form a body corporate under and pursuant to the provisions of Section 4499 of the Revised General Statutes of Florida, as amended by Chapter 10095 of the Laws of Florida for the year 1925 entitled, "An Act to Amend Section 4499 of the Revised General Statutes of Florida Relating to Authority to Incorporate and Manner of Incorporation of Corporations Not for Profit ", do hereby execute and adopt the following Charter.

(1) The name of said corporation shall be CHRISTIAN CHURCH SEBRING, FLORIDA.

(2) The general nature and object of the corporation shall be to conduct a Church organization.

(3) The qualifications of members and their admission shall be based upon confession, repentance and baptism as obedience to faith in Jesus Christ as Saviour.

(4) The existence of said corporation shall be perpetual.

(5) The names and residences of the incorporators and subscribers are as follows, to-wit:

(6) The officers of the corporation shall be three (3) elders at the present time, which number may be increased to six (6) or nine (9); five (5) deacons and deaconesses at the present time, which number may be increased to ten (10), fifteen (15) or twenty (20). The term of office of each elder and each deacon and deaconess shall be three (3) years, and at the first election they shall be elected for such term of office that the term of office of one-third of the elders and one-third of the deacons and deaconesses shall expire each year.

(7) The officers of the corporation shall be elected by the congregation at the annual meeting, which shall be held on the first day of June in each year.

(8) The names of the officers who are to manage the affairs of the said corporation for the first year, or until the first election under the charter, shall be as follows, to-wit:

Elders:

Oriles G. White, A. A. Henderson, C. T. Rogers.

Dacons and Deaconesses:

H. J. Tripp, J. E. Parker, J. I. Warner,

Jack Cleaver Jr., (Mrs.) Carrie Hielke.

(9) The by-laws of the corporation are to be made, altered or rescinded by the congregation, *upon at least one week notice by an announcement from the pulpit at a regular Sabbath morning devotional service.*

(10) The highest amount or indebtedness or liability to which the corporation shall at any time subject itself shall be Fifty thousand (\$50,000.00) dollars, but which shall never be greater than two-thirds of the value of the property of the corporation.

(11) The amount in value of real estate which the corporation may hold, subject always to the approval of the Circuit Court Judge, shall be Three hundred thousand (\$300,000.00) dollars.
