

## ARTICLES OF AMENDMENT TO

### ARTICLES OF INCORPORATION

OF

#### PHAP LAC, INC



Pursuant to the Provision of section 617.1002, Florida Statute, this corporation adopts the following Article of Amendment to its Articles of Incorporation

#### 2. Amendments adopted:

Article III is amended to read:

#### ARTICLE III PURPOSES

This Corporation is organized exclusively for religious purposes, creating and opening a Buddhist Temple, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article VIII is added, and it reads:

#### ARTICE VIII EXEMPT ORGANIZATION AND ACTIVITIES

No part of the net earnings of the Corporation shall insure to the benefit of, or be distributable to its members, trustees, officers, or the private persons, except that the Corporation shall be authorized and empowered to pay the reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attending to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article IX is added and it reads:



#### ARTICLE IX DISPOSITION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

3. Member's vote is not required to adopt an article of amendment, and this Article of Amendment was adopted by the Board of Directors on August 20, 2018.
