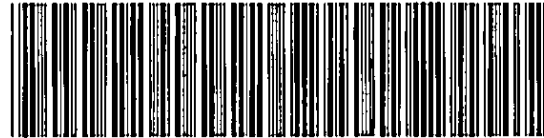

Article IX

Statement of Dissolution

Upon the dissolution of Restoration Fellowship Church, none of its funds or assets shall be distributed to any Pastor, Officer, Council Member, or any other individual. The Vision Council, after paying or making provision for the payment of all liabilities of Restoration Fellowship Church, shall dispose of all the funds and assets of the church by conveying the same to a like-minded church in the Lakeland vicinity unless otherwise stated by the congregation. The recipient organization must qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code.

In the event that the chosen church is unable or unwilling to accept the transfer of all the property of this church, then such property shall be transferred to an organization operated exclusively for religious purposes with tax-exempt status under Section 501(c)(3) of the Internal Revenue Code whose purposes are nearest the purposes of Restoration Fellowship Church, which transfer shall be made by the appropriate court of the county in which this church is located.
