# AMENDED AND RESTATED ARTICLES OF INCORPORATION OF TRABAJO Y PERSONA FOUNDATION INC.

**TRABAJO** Y **PERSONA FOUNDATION** INC. a corporation organized and existing under the laws of the State of Florida, with its head office located at 7460 SW 131 St. Pinecrest, Fl. 33156, hereby adopt the following amended and restated articles of incorporation for such corporation.

### 1. Name of the Corporation

The name of the corporation, hereinafter referred to as the "Foundation" is **TRABAJO** Y **PERSONA FOUNDATION INC.**

#### 2. Period of Duration.

The period of duration of the Foundation is perpetual.

#### 3. Purposes of the Foundation

Trabajo y Persona Private Foundation is a corporation incorporated and organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code (or foreign equivalent organizations) and under the generally referred to Chapter 617 of the Florida Statutes. The Foundation will raise money from supporters, donors and allies for the promotion and development of social projects in Latin America; with focus on job placement for low-income families. Trabajo y Persona Foundation's mission is to promote and raise awareness, and necessary funding for these programs. Our goal is to support unassisted lowincome individuals in Latin America by providing job and career positioning; including, capacitation and training programs, and the promotion of the culture of work and entrepreneurship in all its expressions. Our vision is to develop programs that strengthen vocational and technical training for young individuals within proper educational and financial resources. In addition, this Foundation has been formed for the purpose of performing all things incidental to, or appropriate in, the foregoing specific and primary purposes. However, the Foundation shall not, except to an insubstantial degree, engage in any activity or the exercise of any powers which are not in furtherance of its primary non-profit purposes.

The Foundation may receive and administer funds for scientific, medical and charitable purpose, within the meaning of section 501(c)(3)of the Internal Revenue Code and to that end the Foundation is empowered to hold any property, or any undivided interest, therein without limitation as to amount or value, to dispose of any such property and to invest, reinvest or deal with the principal or the income in such manners, in the judgment of the directors, will best promote the purposes of the Foundation, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the Bylaws of the Foundation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the

pecuniary profit or financial gain of its directors or officers except as permitted under Not-for-Profit Corporation Law.

#### 4. Earnings

No part of the net earnings of the Foundation shall inure to the benefit of any member, trustee, officer of the Foundation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Foundation affecting one or more of its purposes, and no member, trustee, officer of the Foundation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Foundation. No substantial part of the activities of the Foundation shall not participate in, or intervene in, including the publication or distribution of statements, any political campaign on behalf of any candidate for public office.

#### 5. Dissolution

Upon the dissolution of the Foundation or the winding up of its affairs, the assets of the Foundation shall be distributed exclusively to one or more charitable, religious, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the court of applicable jurisdiction in the county in which the principal office of the Foundation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

#### 6. Qualifications for members

The qualifications for members and the manner of their admissions shall be regulated by the Bylaws.

#### 7. Territory

The territory in which the operations of the Foundation are principally to be conducted is the United States of America and its territories and possessions, but the operations of the Foundation shall not be limited to such territory.

#### 8. Directors

The Foundation shall be managed by a Board of Directors. The qualifications for members of the Board of Directors and the manner of their admissions shall be regulated by the Bylaws

#### 9. Registered Agent

Maria Teresa Lopez , with an address of  $\,$  7460 SW 131 St. Pinecrest, FL 33156 is designated as registered agent of the Foundation.
