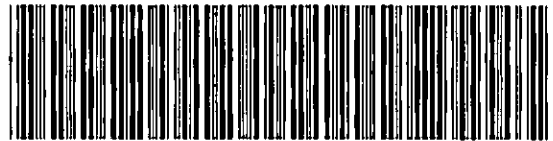

~~ARTICLE II SECTION 2~~ "The Principal Office and Registered Agent of the Corporation shall continue as fixed in the Articles of Incorporation until change by the Board of Directors. There shall be kept activities and transactions of the Corporation, which shall contain a copy of the Certificate of Incorporation, a copy of our By-Laws and all Amendments thereto and all minutes of meetings of the Board of Directors."

~~ARTICLE III SECTION II PURPOSE~~ "Notwithstanding any other provisions contained to the contrary, the Corporation is organized for and shall be operated exclusively for charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended or the corresponding provision of any future United States Internal Revenue Law and shall be constructed in accordance therewith. We are a Christian Based Mentoring and Tutoring Provider for all children, but mainly, disadvantaged children."

~~SECTION II ACTIVITIES~~ "Notwithstanding any other provision contained herein to the contrary, the Corporation shall not carry on any activity not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c)(3) of the Internal revenue Code of 1986, as amended, or the corresponding provision of any future United States Revenue Law. The Corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property of the Corporation and no part of its net earnings shall inure to the benefit of any Director, other individual or the private individual. The Corporation shall not engage in a regular business of any kind ordinarily carried out for profit or in any other activities except in furtherance of the purposes set forth above. The Corporation shall not participate in any political campaign on behalf of any candidate for public office, nor shall any part of its property or income therefrom be devoted to such purpose, nor shall more than a substantial part of its activities consists of carrying on propaganda or otherwise attempting to influence legislation, except as otherwise permitted in Section 501(h) of the Internal Revenue Code of 1986, as amended."

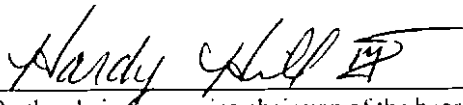
