**Women in Leadership Global Foundation, Inc.**  
**Articles of Incorporation, Non-Profit Attachment**

**Article VIII- Additional Provisions:**

1. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distribution to organizations that qualify as an exempt organization under section 501 © 3 of the Internal Revenue Code, or the corresponding section of any future federal code.
2. No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private person, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and/or to make payments and distributions in furtherance of the purposes set forth in the purpose clause and/or reimburse payments made on behalf of said corporation.
3. The manner of distribution of assets in this Corporation's winding up is as follows: Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © 3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or state or local government for public purpose. Any such asset not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purpose.
