Attachment to the Articles of Amendment

of the

Articles of Incorporation of Willow Cares Inc.

Article III of the Articles of Incorporation of Willow Cares Inc. is hereby deleted in its entirety and shall be replaced as follows:

Article III

The corporation is organized for the charitable purpose of furnishing free home repairs and maintenance services to military personnel, disabled veterans and their families who reside in the St. Petersburg and Tampa areas of Florida. The corporation recognizes that military personnel and veterans, some of whom are disabled, often do not have adequate resources to repair or conduct routine maintenance to their homes. The corporation wants to see to it that such military persons, veterans, and their families are able to reside in "livable" homes, even if they cannot sometimes afford the cost of repairs. Accordingly, the corporation will furnish home repair and other related services free, and at no cost, to military personnel, veterans and their families.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
