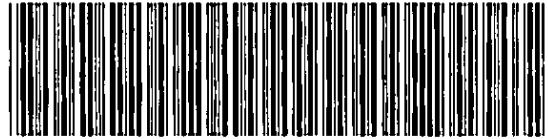

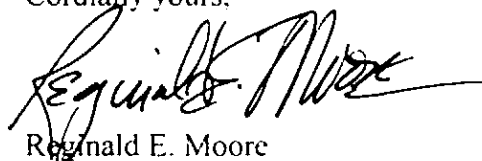

**ARTICLES OF INCORPORATION
THE RUSS INSTITUTE OF HAIR, INC.
A Florida Nonprofit Corporation**

THE UNDERSIGNED incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation shall be: *THE RUSS INSTITUTE OF HAIR, INC.*

ARTICLE II

PRINCIPAL OFFICE AND CORPORATE ADDRESS

The principal place of business and mailing address of this corporation shall be:
248 Dr. M. L. King Blvd.
Daytona Beach, F L 32114

ARTICLE III

PURPOSE(S)

This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. The specific purposes of this corporation are:

A. To provide continuing educational and instructional hours for barbers, beauticians and cosmeticians. To provide an academic environment for state license preparation. To provide seminars and workshops. To coordinate student placement.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

D. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or its successor, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV

BEGINNING OF CORPORATE EXISTENCE AND DURATION

The existence of this corporation shall commence on the earliest day allowable by Florida law. The duration of the Corporation is perpetual.

ARTICLE VI

INITIAL BOARD OF DIRECTORS

The initial directors shall hold office for the first year of existence of this corporation or until his successor is elected or appointed and has qualified.

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

ARTICLE VII

OFFICERS

The officers of the Corporation shall be a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws or resolution of the Board. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws or resolution of the Board. 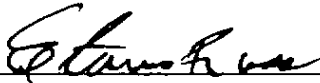
ARTICLE X
