**ARTICLE III. PURPOSE**

The purpose for which the Corporation is organized is:

To do any and all actions, activities, ministries, outreach, and meetings normally associated with, and part of, the functioning of a church.

To produce, distribute, and offer for distribution all forms of printed matter, including, but not limited to, tracts, Bibles, religious books and pamphlets, and to distribute similar types of materials in recorded form.

To broadcast worship services, via the Internet or other media or technology outlets; to engage in the conducting of religious worship services both at the church facilities and at public forums.

To solicit, collect, receive, accumulate, administer, and disburse funds in such a manner as will, in the sole discretion of the Board of Directors, most effectively operate to further the religious purposes, to make contributions to any organization described in Section 501(c)(3) of the Internal Revenue Code of 1954, with the exception of organizations testing for public safety, and to engage in any and all lawful activities incidental to the foregoing purposes, except as restricted herein.

The Corporation shall neither have nor exercise any power, nor shall it directly or indirectly engage in any activity that would (1) prevent it from obtaining exemption from federal income taxation as a corporation described in Section 501(c)(3) of the Internal Revenue Code of 1954, or (2) cause it to lose such exempt status.

The Corporation shall not be operated for the primary purpose of carrying on a trade or business for profit.

No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation; nor shall it in any manner or to any extent participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office; nor shall the Corporation engage in any activities that are unlawful under the applicable federal, state, or local laws.

In the event of dissolution, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the federal, state, or local government for exclusive public purpose.

Notwithstanding any other provision of these Articles, the purposes of this Corporation are exclusively religious, charitable, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954.
