ARTICLE I

Name of Corporation

The name of the corporation is Somerset Clay HOA, Inc.

ARTICLE II

Commencement And Duration of Corporate Existence



Corporate existence shall commence on the date these Articles are filed by the Department of State and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III Corporate Purpose

The specific purpose for which the corporation is organized is to operate a community as defined by Chapter 720 of the Florida Statutes including but not limited to any lawful purpose authorized by Chapter 720 of the Florida Statutes related thereto. The corporation shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit no. 146091-1 requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system. The corporation shall levy and collect adequate assessments against members of the corporation for the costs of maintenance and operation of the surface water or stormwater management system.
