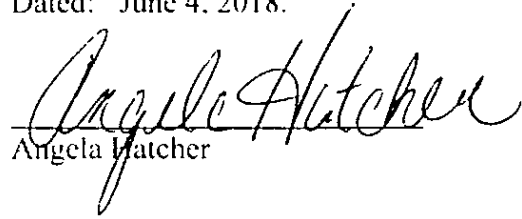

**ARTICLES OF INCORPORATION
OF
GENESIS PLACE, INC.
a Florida Not-For-Profit Corporation**

The undersigned, acting as incorporator of a corporation desiring to form a not-for-profit corporation under the provisions of Chapter 617, Florida Statutes and Section 501(c)(3) of the IRC, do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: **Genesis Place, Inc.**

ARTICLE II

The initial principal address and mailing address of the corporation is:

204 S. Meteor Avenue, Clearwater, Florida 33765

ARTICLE III

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to the organization that qualify as exempt organizations under section 501(c)(3) or corresponding sections of any future federal tax code.

In addition the corporation is organized for the following purposes:

1. To operate exclusively for charitable faith-based addiction recovery housing.
2. To conduct programs, meetings, events and activities; raise funds, request and receive grants, gifts, and bequests of money.
3. To make expenditures to or for the direct benefit of the corporation's operation and purposes.

ARTICLE IV

The corporation shall not:

1. Engage in any activities prohibited by Section 617.0105, Florida Statutes;
2. Carry out propaganda or otherwise attempt to influence legislation;
3. Participate or intervene, by publication or distribution of any statement or otherwise, in any political campaign on behalf of any candidate for public officer;

4. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted under Section 501(c) (3) of the Internal Revenue Code.

ARTICLE V

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private person, except that this corporation shall be authorized and empowered to pay reasonable compensation for services

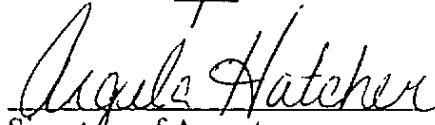

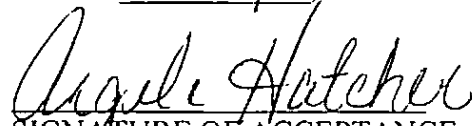
