Articles of Incorporation

The undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation in compliance with Chapter 617F.S. (Not for Profit), do hereby certify:

Article I, Name: The Corporation shall be The Friends of the Noble School, Inc.

Article II, Principal Office: The place in this state where the principal office of the Corporation is to be located is:

419 5th Ave North Jacksonville Beach, FL 32250

Article III. Purpose: Said corporation is organized exclusively for charitable, religious. educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Specifically, without limiting the generality of the foregoing, the purpose of the corporation is to accept donations in order to generally assist The Noble School, and provide scholarships for families that would otherwise qualify for the McKay Scholarship program but are ineligible due to various circumstances, or to qualifying families who demonstrate a financial need of assistance to bridge the gap between their McKay Scholarship and the actual tuition costs, as defined in the bylaws.

Article IV, Manner of Election: The directors of the corporation shall be elected in accordance with the methods specified in the bylaws.

Article V. Initial Directors: The names and addresses of the persons who are the initial trustees of the corporation are as follows:

Article VI, Registered Agent: The name and address of the registered agent is:

Article VII, Incorporator: The name and address of the incorporator is:

Article VIII: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article IX, Dissolution: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate. I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
