

## Restated Articles of Incorporation 8:36

## Palm-Cedar Ministries, Inc.

Florida Not for Profit Corporation

The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, F.S., (Not for Profit).

#### Article 1 Name

The name of this corporation shall be Palm-Cedar Ministries, Inc.

### Article 2 Principal Office

#### Article 3 Purpose

The specific purpose for which the corporation is organized is to teach and preach the gospel to all people; establish places of worship; conduct evangelistic and humanitarian activities; license and ordain ministers of the gospel; facilitate rehabilitation through various forms of support; provide spiritual oversight and direction for other organizations which will themselves be organized and operated exclusively for educational, charitable, and/or religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and shall voluntarily be partnered with this organization; and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code. carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or: (b) by a corporation, contributions to which are deductible under Section 170(C) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue laws.
