The following paragraphs are added at the end of Article III: Specifically, this corporation is founded to establish and maintain a House of Chabad Orthodox Jewish Worship and there to provide Jewish religious worship services, education, cultural activities, social programs, celebrations, spiritual events and humanitarian services to the Jewish communities and to the general communities as well as to any persons worldwide encouraging acts of kindness and unity, and universal harmony for all humanity. It will carry out all its activities according to Jewish tradition as based on the Code of Jewish Law (Shulchan Aruch) by Shneur Zalman of Liadi and other canonical texts of of traditional Judaism and Chabad customs, as understood by its Rabbi, Sholom Namdar. It will be empowered to contract, borrow funds, rent, buy or sell personal or real property. Rabbi Namdar has been appointed Rabbi of this corporation according to Jewish law, with authority in all matters pertaining to Ethics, Spirituality and Jewish Law, including the sole right to determine which matters should be regarded as matters of Ethics, Spirituality and and Jewish Law. This corporation shall not, except to an insubstantial degree, engage in activities or exercise powers that are not in furtherance of its primary purpose. This corporation is empowered to supply all the foods, religious items and physical constructions/properties required. all Jewish needs, including but not limited to Religious Articles, Kosher Food, Ritual Immersion Pools, or transportation to any event or location which in the view of the Rabbi is required in the fulfillment of Religious Duties. It will be entitled to O charge a price for making such religious resources available. This corporation is empowered to send emissaries to any place in the world where it can advance the rectification and world and prepare for the final, complete redemption. This corporation is organized exclusively for religious charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. It will not distribute dividends to any persons, influence legislation or participate in political campaigns of any sort. In the event of this corporation's dissolution, all remaining assets will be distributed to other 501(c)(3) recognized charitable corporations with similar goals.
