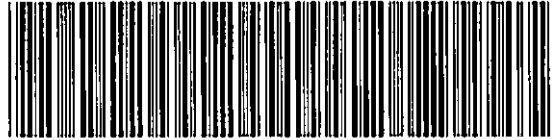

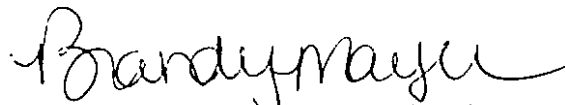

The undersigned acting as sole incorporator of a corporation (the "Corporation") not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following articles of incorporation for the Corporation.

**ARTICLE I  
Name**

The name of the Corporation is: **SISTERS OF SEKHMET, INC.**

**Address**

The mailing address and principal place of business of the Corporation is: 8710 W. Hillsborough Avenue, Suite 364, Tampa, Hillsborough County, Florida 33615.

**ARTICLE II  
Purpose**

The Corporation is a not for profit corporation. The purposes for which the Corporation is incorporated is as follows:

(a) The specific and primary purpose for which this Corporation is formed is to develop and promote a solution to the current cultural environment of females not helping one another and work to identify a potential solution in order to accelerate women's success, and all other purposes permitted by Florida Statutes, §§ 617.01011 et seq.

(b) The general purposes for which this Corporation is formed are to operate exclusively for charitable and educational purposes which will qualify it as an exempt organization under 26 U.S.C.A. §501(c)(3), or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Section.

(c) This Corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

(d) On the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for religious or charitable purposes and which has established its tax exempt status under 26 U.S.C.A. §501(c)(3), or corresponding provisions of any subsequent federal tax laws.

### **ARTICLE III**

#### **Initial Registered Office and Agent**

The registered agent of the Corporation and its initial registered office is: Ronald H. Trybus, Esq., Kass Shuler, P.A., 1505 N. Florida Ave., Tampa, Florida 33602.

### **ARTICLE IV**

#### **Directors/Officers**

The initial number of members of the Board of Director's shall be Four (4). The number of Directors may be increased or decreased from time to time as set forth in the bylaws of the Corporation, provided that the Corporation shall have a minimum of Three (3) and a maximum of Ten (10) Directors.

The initial Directors shall be appointed by the Members. Thereafter Directors shall be elected by the members in accordance with the Bylaws of the Corporation.

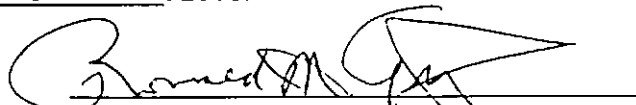
**ARTICLE VI**
