ARTICLE I: NAME

The general purpose of this Council is:

- (a) To facilitate the awareness and involvement of citizens through education, training, and volunteer service programs that include but are not limited to those central to the FEMA sponsored Citizen Corpsituture, for communities to be safer, stronger, and better prepared to respond to crime, hazards, dangers, potential disasters and emergencies that may occur.

- (i) No part of the activities of the Council shall attempt to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.
- (j) No part of the net earnings of the Council shall inure to the benefit of any Officer, Director, or member of the corporation; and upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the Council, dispose of the residual assets of the corporation exclusively for the stated purposes of the Council in such manner, or to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any future Internal Revenue Code.
