This corporation shall have members. The eligibility, rights and obligations of the members will be determined by the organization's bylaws.

ARTICLE 9 TERMS AND DISSOLUTION

The date of commencement of corporation of the corporate existence shall be when these article have been filed with the Department Of State and approve by it the respective filling fee has been paid; the term for which the corporate is to exist shall be perpetual. Any such assets not disposed of shall be disposed of by court of competent jurisdiction in the county in which the principal office of the organization is then locate, exclusively for such purpose or to such organization or organizations as said court shall determine, Which are organized and exclusively for such purpose.

ARTICLE 10 NON PROFIT ORGANIZATION

No part of the net earnings of the corporation shall ever inure to the benefit of, or be distributable to its members, directors, or others private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and make payments and distributions in furtherance of purposes. Set forth in article 3 substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporate shall not participate in, or intervene in (including the publishing or distributions of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any others activities not permitted to be carried on:(a) by a corporation exempt from Federal Income Tax Sections 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue Law or;(b) by a corporation, contributions to which are deductible under Sections 170 (c) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Laws.

ARTICLE 11 BYLAWS

The fist bylaws of the corporation shall be adopted by the board of directors and may be amended, altered or rescinded by the board of directors in the manner providedby such bylaws.

ARTICLE 12 AMENDMENTS TO ARTICLE OF INCORPORATION

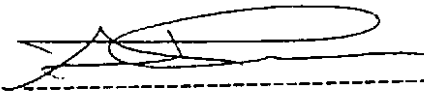
