Notice is hereby given that the undersigned incorporator, boing of full age, for the purpose of forming a corporation not-for-profit, without capital stock; under the provisions of Chapters 607 and 617, Florida Statutes, do hereby accept all rights, privileges, benefits and obligations conferred and imposed by said law, and do hereby make, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is as follows:.

ARTICLE II - PRINCIPAL OFFICE, REGISTERED OFFICE and AGENT

F. In the event of the complete or partial liquidation or dissolution of the corporation, whether voluntary or involuntary, no member, director or officer shall be entitled to any distribution or division of the corporation's property or its proceeds, and the balance of all money and other property received by the corporation from any source, after the payment of all debts and obligations of the corporation, shall be used or distributed, as provided by law and by the Bylaws of the Corporation, exclusive to an organization or organizations which themselves are exclupt as organizations described in Code Sections 501(c)(3), 2055(a) and 170(c)(2) (or any corresponding provisions of succeeding law).
