We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under Chapter 617 of the laws of the State of Florida, applicable to corporations not for profit, under the following proposed charter:

ARTICLE I NAME

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

This Corporation is organized for the purpose of proclaiming the Gospel of Jesus Christ through preaching the Word and ministering to the needs of others through education, sports, water wells, trade schools and providing basic necessities of life while teaching and training others to be disciples of Jesus Christ and do likewise. The purpose of the Corporation shall be carried out worldwide without regard to race, sex, color, ethnic or national origin.
