ARTICLE III: PURPOSE**

The purpose of the corporation, known as Warrior Community Support Outreach Incorporated, is to uplift and empower veterans living in Florida through providing emotional support and health resources / education to make them feel well-adjusted and reacquainted to civilian life.

The corporation is organization exclusively for charitable, religious, educational, or scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
