ARTICLE VIII MEMBERS

The corporation shall not have any members.

ARTICLE IX PRIVATE FOUNDATION REQUIREMENTS

In conducting its activities and carrying out its purposes, the corporation shall (at any time that it is a private foundation as defined in Section 509(a) of the Internal Revenue Code, or corresponding section of any future federal tax code) comply with the following:

- (a) The corporation will distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code, or corresponding section of any future federal tax code.
