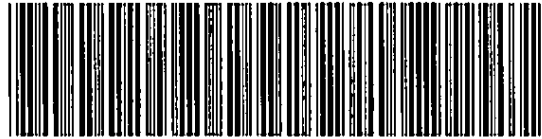

The organization that receives the assets of Cobras Basketball Booster Club Inc., shall be selected by the Board Members of Cobras Basketball Booster Club.




