ARTICLE III PURPOSE

The purpose for which the corporation is organized:

TCE is a 13 member string ensemble conducted by Bulgarian-born Guerguan Tsenov. The central mission of TCE is to introduce to American audiences the music of great composers who are virtually unknown outside of their homelands due to political oppression, but whose music deserves to take its rightful place on the international concert stage. We strive to foster greater appreciation of contemporary classical music by innovative concert programming in which landmarks of modern music are discussed and performed, with a special emphasis on Bulgarian music. To that end, we wish to work closely with other artistic and educational institutions such as universities, museums and dance companies to educate audiences on the exciting complexity of contemporary classical music.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

To become a director, a person shall be elected by a majority of the Board, and each shall hold office for a term of one year or such other term as approved by a majority of the board, until the election of a successor.
