

## ARTICLES OF INCORPORATION OF GO BROWARD, INC.

These Articles of Incorporation are hereby made and acknowledged by the undersigned, who desires to form a not-for-profit corporation under the Florida Not For Profit Corporation Act (Chapter 617, Florida Statutes) and do hereby certify:

#### Article 1. Name and Principal Office

The name of this Corporation shall be **Go Broward, Inc.** The street and mailing address of the place of business in Florida is:

### Article 2. Corporate Purposes

The corporation shall be a corporation not-for-profit pursuant to Chapter 617, Florida Statutes, formed and operated exclusively for the promotion of social welfare within the meaning of Section 501(c)(4) of the Internal Revenue Code. The primary purpose of the corporation is to further the common good and general welfare of the Broward County community by promoting citizen awareness and public discourse through education and advocacy on the economic impact and other implications of the Broward County transportation system sales surtax. The corporation may engage only in activities that may be carried on by a corporation exempt from Federal income taxes under Section 501(c)(4) of the Internal Revenue Code or the corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of any member, except that the corporation may pay reasonable compensation for services rendered and may make payments or distributions in furtherance of the purposes set forth herein.

#### Article 3. Powers

The Corporation shall have and exercise all powers accorded not-for-profit corporations under the laws of the State of Florida.

#### Article 4. Term of Corporate Existence

This Corporation shall exist perpetually unless dissolved according to law.

#### Article 5. Board of Directors; Manner of Election

The powers of the Corporation shall be exercised by or under the authority of, and the affairs of the Corporation shall be managed under the direction of, a Board of Directors, the number of which may be either increased or decreased from time to time as regulated by the Bylaws. The manner and method of election of the Board of Directors shall be as stated in the Bylaws of the Corporation. Where not inconsistent with Chapter 617, Florida Statutes, and the express provisions of these Articles of Incorporation, the Board of Directors shall have all the rights, powers, and privileges prescribed by law of directors of corporations for profit.

#### Article 6. Officers

The Corporation shall have a president, a secretary, and a treasurer and may have additional and assistant officers including, without limitation thereto, one or more vice-presidents, assistant secretaries, and assistant treasurers. A person may hold more than one office. The manner and method of election of the officers shall be as stated in the Bylaws of the Corporation.

#### Article 7. Amendment

These articles may be amended as set forth in the Bylaws of the corporation. Until Bylaws have been adopted, these articles may be amended as provided in Chapter 647, Florida Statutes, or any statute adopted in succession thereof.

#### Article 8. Dissolution

Upon dissolution, all of the Corporation's assets remaining after payment of all costs and expenses of such dissolution shall be distributed in a fashion established under the Bylaws of the Corporation, subject to the requirements of Section 617.1406, Florida Statutes. None of the assets shall be distributed to any officer, director, or member of the Corporation, or any other person or organization not described in the preceding sentence.
