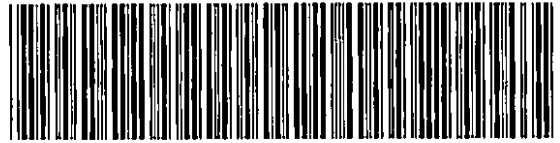

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is Florida Elite Boosters, Inc.




