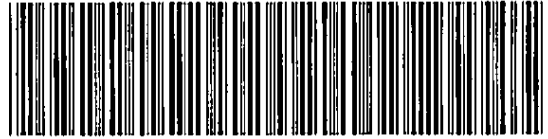



## ARTICLES OF DISSOLUTION

Pursuant to §617.1403, *Florida Statutes*, the Florida not for profit corporation delineated below submits the following Articles of Dissolution:

### **FIRST:**

The name of the corporation being dissolved is "**First Mizo Community Church, Inc.**"

### **SECOND:**

The document number of the dissolving corporation is **N18000007223**

### **THIRD:**

A meeting of members of the Church was validly called and held in accordance with the Church's bylaws on or about 10/30/2022. At such time a resolution to dissolve the Church was adopted by the members eligible to cast a vote. The final tally of such vote was as follows:

A total of 12 votes were cast.

9 were in favor of the resolution.

3 were opposed.

The result of the vote was to approve the dissolution of the Church.

### **FOURTH:**

The effective date of this dissolution shall be December 31, 2022.

### **FIFTH:**

As part of the approved resolution to dissolve the church corporation, the members voted to transfer all of the Church's assets to The Southside Baptist Church of Jacksonville, Florida, Inc. (d/b/a Aspire Church). Upon such transfer, First Mizo Community Church, Inc. shall have no further assets or known obligations to any third party(ies).


