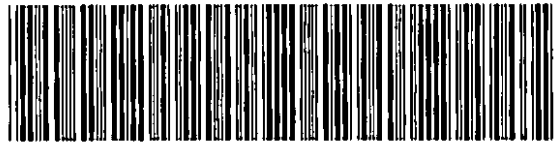

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

1.01 Name

The name of this corporation shall be RAYOH, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

3.01 Purpose

RAYOH, Inc. is organized exclusively for charitable, religious, educational, or scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code. RAYOH, Inc. exists to help vulnerable and impoverished individuals and communities worldwide to alleviate hunger, disease, endemic poverty, the effects of disasters, and to maintain human dignity through short-term relief and long-term sustainable solutions fostering self-reliance.

3.02 Non-Profit Nature

Said corporation is organized exclusively for charitable, religious, educational, or scientific purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No part of the earnings of the corporation shall inure to the benefit of or be distributable to any private individual or person; provided, however, that the

corporation may pay reasonable compensation for services rendered to it and reimbursement of expenses reasonably incurred on its behalf. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distributing of statements), any political campaign on behalf or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not have the power to carry on any activities which would cause it to fail to qualify, or to fail to continue to qualify, as (i) an organization exempt from federal income tax under section 501 (c)(3) of the Code, or (ii) an organization to which contributions are deductible under section 170(c)2 of the Code

3.03 Dissolution

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.

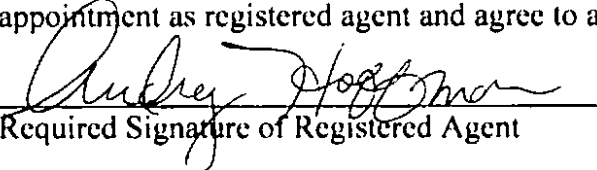

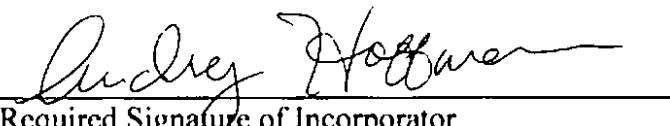
