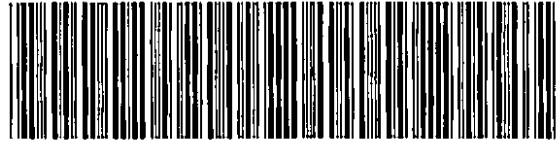

ARTICLES OF INCORPORATION

For

RESTORE AMERICA PROJECT, Inc.

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I

Name: The name of the corporation shall be: Restore America Project, Inc.

ARTICLE II

Principal Office: The Principal Office of the Corporation shall be:

14007 Snowy Owl Lane, Winter Garden, Florida 34787

ARTICLE III

Purpose: The Corporation is organized exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, for such purposes including, but not limited to, further the common good and general welfare by educating the public about policies and advocating for smaller government.

ARTICLE IV

Non-Inurement: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above in Article III.

ARTICLE V

Dissolution: Upon the dissolution of the corporation, assets shall be distributed to a like organization exempt under the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in

which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.






