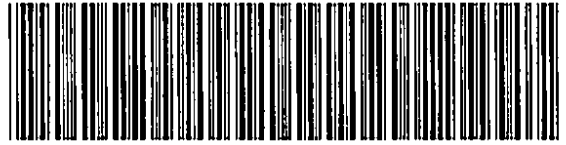

## ARTICLE TWELVE LIMITATION OF POWERS

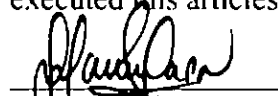

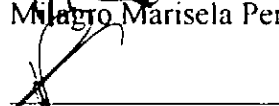
The corporation shall not endorse political candidates nor promote legislation.

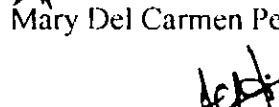
## ARTICLE THIRTEEN DISSOLUTION CLAUSE

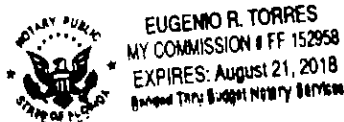

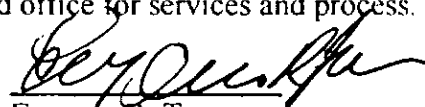
