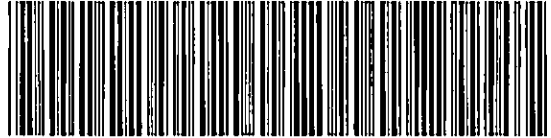

This is to certify: that the undersigned members of the Board of Directors of **Manor Park Friends Forever, Inc.** whose address is **1730 NW 154th Street, Miami Gardens, Florida 33054**, being of the United States and of the State of Florida, and acting as incorporators, do hereby form a non-stock corporation for the promotion and conduct of the purposes and subjects hereinafter stated, under and by the General Laws of the State of Florida and the United States of America.

The undersigned incorporators, for the purposes of forming a corporation under the Florida Nonprofit Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The period of duration of this Corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles of Incorporation. The undersigned incorporator, for forming a Florida Non-Profit Corporation, hereby adopts the following Articles of Incorporation.

ARTICLE III

GENERAL AND SPECIFIC PURPOSES

The purposes of the Manor Park Friends Forever is to support, promote and advance community participation. The objectives of the corporation are exclusively charitable and educational and to seek, cultivate and obtain revenues to be used for developing and expanding opportunities for the community in Liberty City and the Model City. The corporation is empowered to solicit, obtain, accept and receive gifts, donations, legacies and contributions and for its operations; to execute all contracts for the essential needs of the corporation and for carrying out its objectives and purposes; and to do all other lawful acts necessary or desirable to carry out its purposes.

Manor Park Friends Forever works to identify community needs, inspire community involvement, the solution being amongst other things are to keep the community healthier, by contributing through projects that assist and empower families and groups in the Liberty City and The Model City area. Manor Park Friends Forever supports the community assisting one neighbor at a time to overcome limiting circumstances and free from poverty, violence, and inequality. Manor Park Friends Forever is to empower, enable and support community in their efforts to revitalize Liberty City and The Model City Community neighborhoods. Manor Park Friends Forever serves as a vehicle through which residents and businesses can work together to solve problems and improve life in their community. MPFF will serve the community with compassion, integrity, transparency, and respect. Education is the key, Literacy is the foundation for improving the quality of life in the community, by Promoting education, workforce and community development. Manor Park Friends Forever is driven by the belief that we all can make a difference by giving back, MPFF believe we can transform communities by working together.

To further the Manor Park Friends Forever following activities may be carried out:

1. To initiate, promote and assist in the community to promote and establish programs and activities.
2. To improve the circumstances of the neighborhood's low- and moderate-income residents by reducing the level of unemployment and underemployment through the creation of workshops and Job training.
3. To organize neighborhood residents of all ages to identify and respond to community issues. To work cooperatively with existing public and private agencies toward the effective utilization of human resources in the community.

To achieve these objectives, Manor Park Friends Forever will provide a program(s) that encourages participation. All Directors, and Officers shall bear in mind that we support Manor Park Friends Forever Programs. In accordance with Section 501 (c) 3 of the Federal Internal Revenue Code, the Manor Park Friends Forever shall operate exclusively as a non-profit organization. No part of the net earnings shall benefit any private shareholder or individual; no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to

influence legislation, and which does not participate in or intervene in any political campaign on behalf of any candidate for public office.

The manner in which directors are elected or appointed is: As provide for in the Bylaws.


ARTICLE V






