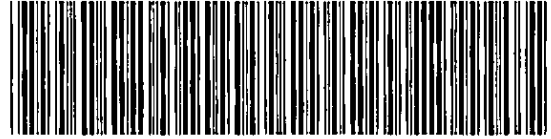

ARTICLES OF INCORPORATION

for

Winter Beach Historical Society, Inc.

In compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of the corporation shall be: Winter Beach Historical Society, Inc.

Article II Principal Office

The principal street address is: 55 Royal Palm Pointe, Vero Beach, Florida 32960

The principal mailing address is: 706 – 41st Avenue, Vero Beach, Florida 32968

Article III Purpose

The purpose for which the corporation is organized is:

1. To protect, preserve, and maintain documents, structures or any other articles relating to the Winter Beach area, exclusively for literary, education and charitable purposes within the means of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
2. To acquire as appropriate any of those items or sites which are determined to further the goals of the Winter Beach Historical Society for reference or display, by donation, purchase or other methods as deemed appropriate.
3. To promote, educate and bring awareness of the historical significance of the Winter Beach area to interested citizens and organizations.

Article IV Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
