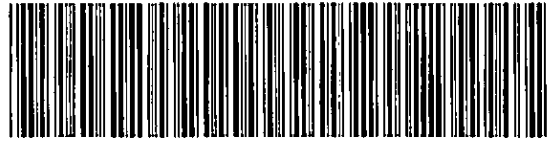

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: NAME

The name of this Corporation shall be: RIVER OF LIFE BETHEL CHURCH, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 5459 Vineland Rd., #4213, Orlando, FL 32811.

ARTICLE III: PURPOSE

The Corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Corporation has in vision to care and lead others into a growing relationship with Jesus Christ through its ministries and activities, fulfilling the Lord's Commission in Matthew 28:18-20.

ARTICLE IV: RESTRICTIONS

NO PRIVATE INUREMENT - No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. The Corporation shall not have capital stock or shareholders.

NO SUBSTANTIAL LOBBYING - No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation.

NO POLITICAL CAMPAIGNING - The corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

IRREVOCABLE DEDICATION – The income and assets of the Corporation shall be irrevocably dedicated to its exclusive purposes.

ARTICLE V: DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE VI: MANNER OF ELECTION

The manner in which the Officers/Directors are elected and appointed shall be contained in the Bylaws.

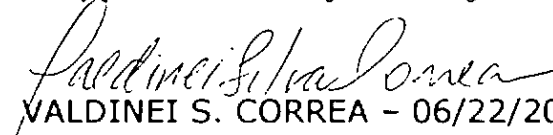
