We, the undersigned, with other persons being desirous of forming a *not-for-profit* corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I - Name & Address

The name of the corporation shall be:

The principal office and mailing address of this corporation shall be:



ARTICLE II - Purpose

Said corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law, and more specifically, the Corporation is organized and shall be operated exclusively to carry out the following purposes:

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding Sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose.

Article IV - Bylaws

The Bylaws of the Corporation are to be made, altered or rescinded by members in good standing.

Article V - Personal Liability

No member, officer, or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VI - Board of **Directors & Officers**

Management of the Corporation shall be vested in the Corporation's Board of Directors, the members of which shall not be less than five and no more than nine. The method of election of corporate directors is as stated in the bylaws. No director or officer shall have any rights, title, or interest in or to any property of the corporation.
