Third: Said Organization is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 50l(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code. In accordance therewith, the purpose for which the Organization is organized is to advance democratic values to all types of governmental institutions and organizations and to provide creative educational programs to individuals and organizations on public policy, management of public and community recourses, and sustainable projects.

Notwithstanding any other provision of these articles, this Organization shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Organization.

Fourth: The Organization shall have as members those persons who are admitted by the Board of Directors, who agree to be bound by these Articles of Incorporation and by the bylaws and policies set forth by the Corporation, and who actively participate in the development of the mission of the Organization.

Fifth: The Organization shall have five (5) directors, out of which one shall be named as President of the Organization and shall chair the meetings of the board of directors, another director shall serve as the First Vice President of the Organization, another director shall serve as the Second Vice President of the Organization, another director shall be be the Treasurer

and another director shall be the Secretary.

Sixth: The manner in which the directors of the Organization are elected and appointed shall be stated in the bylaws of the Organization.

forth in Article Third hereof. No substantial part of the activities of the Organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Organization shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(J) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section I 70(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Eleventh: Upon the dissolution of the Organization, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
