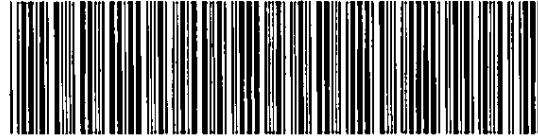

ARTICLES OF INCORPORATION FOR FUND FOR CAUSE INC

The Undersigned Incorporator , for the purpose of forming a Florida not for profit corporation , hereby adopts the following Articles of Incorporation.

Article 1

The name of the Corporation is : FUND FOR CAUSE INC

Article 2

The principal Place of Business Address is : 15615 NE 4TH CT , NORTH MIAMI FLORIDA 33162

The Mailing Address of the Corporation is : 15615 NE 4TH CT , NORTH MIAMI FLORIDA 33162

Article 3.-

The specific purpose for which the corporation is organized :

The Corporation is organized exclusively for Charitable , Religious , Educational , and Scientific purposes , including for such purposes , the making of distributions to organizations that qualify as exempt organizations under 501 (c) 3 of the Internal Revenue Code or corresponding section of any future tax code.

Article 4.-

The Manner in which the Directors are elected or appointed :

The Directors are elected for Three (3) years by the simple majority vote of members , during an election meeting that has reached the regular quorum . If said quorum is not achieved , the election is postponed for 15 days m, and will be organized whatever the number of members present.

Article 5.-

No part of the earnings of the organization shall inure to benefit of , or be distributable to its members , trustees , officers , or other private persons , except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set for in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on propaganda , or otherwise attempting to influence legislation , and the organization shall not participate in , or intervene in , (including the publishing and distribution of statements) any political campaign on behalf of any candidate for public office . Notwithstanding any other provision of this document , the organation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt for Federal Income Tax under section 501 (c) 3 of the Internal Revenue Code or any corresponding section of any future federal tax code , or (b) by an

organization contributions to which are deductible under section 170 (c) 2 of the Internal Revenue Code or Corresponding Section any future Federal Code.

Article 6

Upon the Dissolution of the Organization , Assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) 3 of the Internal Revenue Code or Corresponding Section of any Future Federal Tax Code . or shall be distributed to the Federal Government or to a State or Local Government. For a public purpose , any such assets not disposed of shall be disposed of by the court of common pleas of the county in which the principal office of the organization is located , exclusively for such purposes or to such organization or organizations , as said court shall determine , which are organized and operated for such purposes.

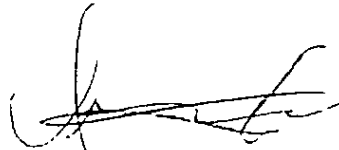
