ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (NON-PROFIT)

ARTICLE I

NAME

1.01 Name

The name of this corporation shall be **IAF TKD Family Dreams Foundation, Inc.**

ARTICLE II

Address

ARTICLE III

PURPOSE

3.01 Purpose

IAF TKD Family Dreams Foundation, Inc. is a non-profit corporation organized exclusively for charitable and educational purposes, within the meaning of §501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations, under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

To maximize our effectiveness, we may seek to collaborate with other non-profit organizations which qualify as non-profit corporations under section 501(c) (3).

3.02 Public Benefit

IAF TKD Family Dreams Foundation, Inc. is designated as a public benefit corporation.

ARTICLE IV

NON-PROFIT NATURE / BENEFITS

4.01 Non-profit Nature

IAF TKD Family Dreams Foundation, Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its charitable and educational purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to, any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles and its bylaws.

4.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of **IAF TKD Family Dreams Foundation, Inc.** of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

4.03 Dissolution

Upon termination or dissolution and upon payment or adequate discharge of all liabilities and obligations of the corporation, any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute), which organization or organizations shall have a charitable purpose.

4.03 Prohibited Distributions

No part of the net earnings, or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the corporation's purposes.

4.04 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.05 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V

BOARD OF DIRECTORS

5.01 Governance

IAF TKD Family Dreams Foundation, Inc. shall be governed by its board of directors.




