**ARTICLES OF INCORPORATION  
OF**

**ARTICLE I.  
NAME**

The name of the corporation shall be Level Up Ministries, Inc. (the "Corporation").

**ARTICLE II.  
PRINCIPAL OFFICE**

The principal and mailing address of the Corporation is 1435 Wyndham Ct., New Port Richey, FL 34655.

**ARTICLE III.  
PURPOSES**

2.1 **General Purpose.** Subject to the provisions of Section 2.2 below, the purposes for which Level Up Ministries (the "Corporation") are organized are exclusively charitable within the meaning of Section 501(c) of the Internal Revenue Code of 1986, as may be amended from time to time, or the corresponding provision of any future United States Internal Revenue law.

2.2 **Specific Purposes.** The primary (but not exclusive) purpose of the Corporation is to provide free consulting services to churches, pastors, ministry leaders, non-profit organizations, international Christian workers and international Christian organizations in the areas of vision casting, strategic planning, leadership development, and community development.

**ARTICLE IV.  
MANNER OF ELECTION**

The Directors of the Corporation shall be elected at the annual meeting of Board of Directors or at any meeting of the Directors held in lieu of such annual meeting. The election shall be decided by a majority vote of the then acting Directors, whether or not constituting a quorum.

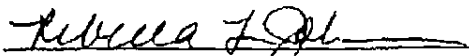
